### **Reservation**

### **Facilities**

Unfortunately, Durham Regatta are unable to provide access to gas, electricity, water or any other utilities. We may be able to arrange marquee cover, or generators at an additional cost. If you require these, please contact the Regatta Secretary.

### **Sub-Franchising**

No sub-franchising arrangements may be entered into without the express permission of Durham Regatta.

### **Health and Safety**

All traders and exhibitors are responsible for the health and safety of their pitch. Durham Regatta may carry out random spot checks with regards to health and safety. Any issues noted must be rectified by the trader or exhibitor immediately.

Traders and exhibitors must have at least one English language speaker in attendance at the Regatta at all times, in order to respond to any Site/Safety team requests.

Traders and exhibitors must ensure that public thoroughfares and emergency access routes are free of obstacles and that all necessary equipment (e.g. fire extinguishers) is in place. In particular, the main bricked path through the Regatta Enclosure must be kept clear at all times. This includes any overhang from your trade stand.

Please note that acceptance of this reservation is subject to provision of the following documentation:

- Risk assessment;
- Public Liability Insurance Certificate (minimum cover of £5m);
- Public Hygiene Certificate (only required if you are selling food).

If you have not provided these with your application, please provide this within **seven days of receipt of this letter**, otherwise your reservation will lapse.

Trade stands and exhibitions that do not comply with health and safety regulations will be asked to leave the site, and the full fee will be chargeable.

### **Access Arrangements**

Vehicular access to the Regatta Enclosure is limited. **No vehicular access will be permitted after 07.45 on Saturday 11<sup>th</sup> and Sunday 12<sup>th</sup> June 2022, and all vehicles on site must leave the enclosure by 08.00.** Vehicular access will be permitted after **19.00** on each day.

Please arrive at the site via Green Lane. At the end of Green Lane, please follow the tarmac road towards Durham Amateur Rowing Club, and take a left turn on to the gravel track just before the entrance to Durham Amateur Rowing Club, towards the river.

On arrival at the Enclosure, please report to Event Control, and ask for **Chris Bell** or **Andrew Curtis**.

Please note that the Regatta Enclosure will be closed to the public from 19.00 on Friday 10<sup>th</sup> June, and you may arrive on the Friday afternoon (after 12 noon). Whilst security cover will be present after 20.00 on Friday 10<sup>th</sup> June 2022, Durham Regatta accepts no responsibility for the security of your trade stand.

Public access to the Regatta Enclosure is by ticket or admission fee only. Please ensure all staff wear the appropriate coloured wrist band for the day, otherwise you may be refused entry at the gate and be charged an admission fee.

### **Other Services**

In addition to trade stands, Durham Regatta can also offer sponsorship, and advertising opportunities. A 25% discount on race sponsorship and programme advertising is available to those trading at Durham Regatta.
